A **bibliography** is a list of sources (books, journals, websites, periodicals, etc.) one has used for researching a topic. Bibliographies are sometimes called "references" or "works cited" depending on the style format you are using. A bibliography usually just includes the bibliographic information (i.e., the author, title, publisher, etc.).

An **annotated bibliography** includes a summary, quote(s), assessment, and an evaluation of each of the sources.

All annotated bibliographies will include the following:

Your source in proper MLA/APA format (your choice but you must be consistent)

·Summarize: Give an overview of the source. What are the main arguments? What is the point of this book or article? What topics are covered? If someone asked what this article/book is about, what would you say? This should be approximately 4 – 6 sentences MAXIMUM.

Direct Quote(s): Choose at least two direct quotes from the source. Place each in quotes and use proper in-text referencing.

Assess: After summarizing a source, evaluate it. Is it a useful source? How does it compare with other sources in your bibliography? Is the information reliable? Is this source biased or objective? What is the goal of this source?

Reflect: Once you've summarized and assessed a source, you need to ask how it fits into your research. Was this source helpful to you? How does it help you shape your argument? How can you use this source in your research project? Has it changed how you think about your topic?

Your 10 annotated bibliographies must include:

ONE INTERVIEW with an “expert” in your field. This can be done via email, phone call or person to person. You should consider contacting colleges to speak to professors of certain subjects. You can call companies that deal with your topic as well. If meeting in person a PARENT/GUARDIAN must accompany you and remain the entire time!

AND

ONE JOURNAL/MAGAZINE ARTICLE on your topic. This can be from Gale or from a reputable journal online/in print.

AND

ONE NEWSPAPER ARTICLE on your topic. This can be from Gale or from a reputable newspaper online/in print.

Works Cited (sample)

Wright, Andrew. *History's Progressive Presidents*. New York: Anchor Books, 1946.

Summary: Wright analyzes three presidents of the early 20th Century. Specifically he examines TR, Taft, and Wilson. In this full length book, Wright analyzes how each progressive president dealt with conflict among workers groups and business leaders. Progressive goals, leaders, and laws are discussed. Wright also analyzes the varied success of each president's legislation. Specifically, he discusses the Pure Food and Drug Act (TR), the Payne-Aldrich Tariff (Taft) and the creation of the Federal Reserve System (Wilson).

Quotes:

“At the time, the Pure Food and Drug Act of 1906 was the most daunting intrusion by federal authorities into interstate commerce” (Wright 121)

“Although other federal agencies could regulate prices and occupational safety, the USDA was now engaged in the regulation of the very manufacture and sale of products, in addition to advertising” (Wright 122)

Assess: This source will be very valuable. Mr. Wright was an eyewitness to this history serving as assistant counsel to the Attorney General during all three presidential terms. His judgment is even and unbiased. His links to modern day will prove helpful.

Reflect: I will use this source in constructing my research paper. Specifically, I am going to use the points Wright made about the impact of the PF and D Act in my conclusion of the paper.
