There are no facilities that house incarcerated students located within the boundaries of the Owen J Roberts School District. Under Sections 1306, 1306.1, and 1306.2 of the Pennsylvania Public School Code of 1949, the school districts in which juvenile and adult detention facilities are located ("host districts") are responsible for finding, identifying, and providing special education services to children with disabilities who are committed thereto. The Owen J Roberts School District facilitates this process by ensuring that all education records and other information necessary to enable the various host districts to conduct evaluations or reevaluations and develop and implement special education programs for adjudicated residents of the District who are or are thought to be disabled are transferred in a timely manner. The host district contracts with the Chester County Intermediate Unit (CCIU) to provide educational services and to ensure that a certified special education teacher is instructing our adjudicated students.

On-going communication with the CCIU staff continues while the students are incarcerated to ensure the Owen J Roberts School District is knowledgeable of the current status of each adjudicated youth and maintains parent contact while their child is incarcerated. When students who are identified as disabled are scheduled to be released from detention, the District makes every effort to schedule meetings at or near the time of discharge to ensure that these students re-enter public school programs with minimal disruption to their special education services. For those students who are moved to other correctional facilities, the CCIU #24 collaborates with the Juvenile Justice Staff to ensure that incarcerated students receive a Free and Appropriate Public Education. Should the incarcerated student complete the requirements for graduation, the student is issued an Owen J Roberts School District diploma in June of that school year.

Least Restrictive Environment

1. Review the district's data for Least Restrictive Environment. Highlight areas of improvement.

In both the 2021-22 & 2022-23 School Years (SY) Special Education Data Report, the Owen J. Roberts School District exceeded the state average (61.5%) for special education students inside the regular class for 80% or more of their day. In 2021-22, OJRSD was at 74.6 % and in 2022-23, 76.9%. Through training and collaboration with general education, special education students are able to be included to a greater extent in the regular education curriculum. In the category of Inside the Regular Class less than 40%, the Owen J. Roberts School District was lower (2.2% in 21-22 & 2.6% in 22-23) than the state average (9.9% in 21-22 & 10.0% in 22-23). Through training and collaboration with general education, special education students can be included to a greater extent in the regular education curriculum and classroom. In the category of Special Education students placed outside the district, the state average for 21-22 & 22-23 was 4.4%. In the 21-22 SY, Owen J Roberts was at 3.4% and decreased to 3.1% in the 22-23 SY. This decrease can be attributed to move-in students placed outside the district transitioning back into district programs and students in outside placement exiting services. Placing students outside district programming is always the last option considered for IEP teams.

2. What universal practices does the district utilize to address the academic and social/emotional needs of all students in need of accommodations to their learning environments?

The IEP team for each student discusses the full range of services needed and the best option for the provision and implementation of those required services prior to reducing student participation in the regular education environment. Various types of supplementary aids and services are also considered, including but not limited to paraprofessional support, personal care aides, increased intensity of in-class support, technology aides, universal design for learning, etc.

3. Describe the academic programming and training efforts the LEA utilizes to ensure meaningful participation of students with disabilities in the general education curriculum.

The Owen J. Roberts School District recognizes the importance of training our general and special education teachers in the curriculum and providing updates on new content and practices to the staff annually to support inclusion in the general curriculum to the greatest extent possible. Special education paraprofessionals are provided training on supporting students in the general education classroom, and the special education teachers model the accommodations and modifications for the paraprofessionals and general education teachers to ensure IEPs are implemented across settings. At the elementary level, academic coaches collaborate with special education teachers and curriculum supervisors to provide coaching and modeling on differentiating the content for all students. The Owen J. Roberts School District began to implement Universal Design for Learning (UDL) professional development starting in the 22-23 school year. Elementary IEP facilitators also provide modeling and coaching for teachers and paraprofessionals on implementing the IEP in the general education setting. Co-teaching and collaborative instruction are available at times and present throughout all levels in the school district and are based on the identified needs of the students. Consultation in the general education classroom is a daily practice throughout all buildings within the district.

4. **Describe the supplementary aids and services the LEA utilizes to ensure meaningful participation of students with disabilities in extracurricular activities.**

Special education staff collaborate with the extracurricular advisors to identify any potential barriers to participation, and then the IEP develops a plan that removes those barriers, such as providing a child-specific aide to support the student, UDL, or arranging specialized transportation.

5. **Describe the District procedures, which ensure that, to the maximum extent appropriate, children with disabilities placed in private institutions are educated with non-disabled children and have the opportunity to participate in district-led extracurricular activities.**

The Owen J Roberts School District recognizes the legal requirements of Least Restrictive Environment (LRE) and utilizes a team approach when considering placements for students with disabilities, beginning with the neighborhood school. Inclusion in the home school setting is always the first option and includes a discussion among the IEP team to determine whether or not building-level supports are sufficient to meet the student's needs. A continuum of services is available in each school building; however, in the elementary buildings, specialized programs, including autistic support, emotional support, and life skill support, are provided in specific elementary buildings. Additionally, supplemental supports and related services are offered within each of the school buildings in order to maximize inclusion, including IU supports through the Training and Consultation department for student-specific training in areas such as behavioral interventions, autism, assistive technology, or vision/hearing. If the student's neighborhood building is not able to provide sufficient supports and services, the team looks to other elementary schools in the district in order to determine whether or not specialized in-district programs can meet the student's needs. If the team determines that the student's needs are such that inclusion in the neighborhood school building would be inappropriate, the team may then review programs outside of the district's buildings, which may include IU programs in specialized centers, cross-district classrooms, or in some cases, approved private school (APS) placements. In all of these extreme situations, district Special Education Supervisors are closely involved with the process in order to ensure that every effort is made to include the student in the neighborhood school where appropriate, including district-led extracurricular activities.

6. **Discuss the district's need to build capacity and expand programs and services in an effort to provide a continuum of services. (Consider the out of district placement chart)**

The Owen J Roberts School District provides a full continuum of services within the district's buildings in the creation and maintenance of specialized center-based programs within the District. These programs boast increased and specialized services that are specifically designed to meet the unique needs of those students who are unable to maximize their potential in their home buildings. These programs help ensure that every student in the District has multiple opportunities for social, emotional, and academic success in their home District. French Creek Elementary School offers both Life Skills Support and Autistic Support programs, while West Vincent Elementary and East Vincent Elementary School also offer Autistic Support programming. These programs are supported through valuable partnerships with the Chester County Intermediate Unit. Such partnerships provide ongoing training and support for the teachers and paraprofessionals within these programs to maximize the potential for success. East Coventry Elementary School offers a specialized Emotional Support program. This program capitalizes on partnerships with the Chester County Intermediate Unit, as well as, Creative Health Services to help meet the unique needs of students requiring this level of intervention. As students transition to the secondary program in grades 7-12+, the District maintains these specialized supports. The District continues to maximize partnerships with state and local agencies, as well as, deliver meaningful professional

development opportunities for all staff. These partnerships and professional development opportunities support the District in developing, implementing, and maintaining high-quality programs that serve to meet the needs of students. At the high school, specifically, we have developed an adult support program that allows us to meet the functional and transition needs of students through the year of their twenty-second birthday. Developing, implementing, and maintaining a high-quality continuum of special education services is a tremendously delicate process. There needs to be careful budget planning, focused recruitment efforts, collaborative professional development and training, and, most importantly, the flexibility to make adjustments to meet the ever-changing needs of students.

1. **How does the district support the emotional, social needs of students with disabilities?**

Positive rather than negative measures form the basis of behavior support programs. The types of intervention chosen for a particular student shall be the least intrusive and necessary and shall be in accordance with Chapter 14. The Owen J. Roberts School District emphasizes a team approach in providing behavior support to students. The range of behavioral support services varies depending on the individual needs of each student and may encompass consultation through direct intervention. Team membership comprises psychologists, guidance counselors, parents, regular and special education teachers, building administrators, instructional support teachers, community-based therapists, etc. By utilizing the professional and personal expertise of team members, the School District can provide an appropriate level of positively based, least restrictive, behavioral intervention measures. All students with disabilities who have behaviors that impede their learning or that of others have specially designed instruction and or goals that address identified behaviors of concern. The IEP team may recommend a Functional Behavior Assessment (FBA) to determine the target behaviors of concern. Once the behaviors are identified, the team analyzes the antecedent behaviors that occurred before the behavior was exhibited. The consequences of the students' behaviors are also documented. The team then analyzes all the shared information. Upon completion of the FBA, the team creates a positive Behavior Support Plan (BSP). This plan systematically addresses the behaviors of concern and reinforces newly learned, appropriate replacement skills using positive reinforcement. The BSP is shared with all staff working with the student to ensure consistent implementation of the plan across all environments. The Training and Consulting (TaC) Team of the Intermediate Unit (IU) provides the support of a Board Certified Behavior Analyst (BCBA) and other specialized consultants in the areas of behavior and autism to the district when requested. Consultants are available to support the IEP team by conducting FBAs and observations. Aversive techniques, restraints, or discipline procedures may not be used as a substitute for a behavior support program. The use of physical restraining methods is permitted only when it is necessary to control acute or episodic behaviors that present a danger to the child or others and only when less restrictive measures have proven to be or are ineffective. Such restraints are never used for the convenience of staff, as a substitute for an educational program, or as punishment. When specified in a student's IEP, social skills training is provided through various staff members such as guidance counselors, student assistance programs, psychologists, instructional support teachers, autistic support personnel, mental health specialists, and special education teachers. In addition, consultants are available through the IU in regard to specific social skills training programs.

2. **Describe training provided to staff in the use of positive behavior supports, de-escalation techniques, and responses to behavior that may require immediate intervention.**

The Owen J. Roberts incorporates all of the requirements and limitations of Section 14.133 of the regulations of the State Board of Education, 22 Pa. Code Sec. 14.133, as the policy of the District and ensures that the Superintendent or his or her designee "shall provide for the regular training and re-training, as needed, of personnel in the use of specific procedures, methods, and techniques that those personnel will be expected to employ in the implementation of behavior supports or interventions in accordance with the IEP[s] of ... child[ren] with disabilities." Training is provided by district supervisors, CCIU TAC team members, and the CCIU BCBA on classroom management, individual student behavior management, and ongoing modeling and coaching in addressing student behaviors. Contracted Registered Behavior Technicians (RBTS) support the implementation of positive behavior support plans in the elementary buildings for identified students and those in the MTSS process. Beginning in the 2018-2019 school year, the district began training response teams in Safety Care safe restraints. Previously, the training program was designed by the Crisis Prevention Institution (CPI). The program provides increased focus on de-escalating the student and behavior management principles. This training and recertification occur annually through the CCIU, and building teams routinely practice responding to an escalated student. A list of trained staff is maintained at the district level, and their re-certification is planned so they remain current. Each year, the building-level administrators identify staff that should be added or removed from the district list. In the 2023-24 SY, the district utilized the Chester County Intermediate Unit to provide Safety Care Basics to all teaching staff, focusing on understanding behavior basics and focusing on de-escalation techniques.

3. Describe the district's positive school-wide support programs.

Behavior support programs include a variety of techniques to develop and maintain skills that will enhance an individual student's opportunity for learning and self-fulfillment. Potential causes of behavior problems, such as physical or medical conditions, environmental factors, staffing, and program concerns, are reviewed and addressed prior to the development of a behavior management program. For each student with a disability who exhibits behavior problems that interfere with the student's ability to learn or that of others to learn, the Individualized Education Program (IEP) shall include provisions for a program of behavior management in accordance with Chapter 14 (relating to special education services and programs). Two of the elementary schools, East Coventry Elementary and North Coventry Elementary, have formal PBIS programs in their schools supported through Chester County Intermediate School. Both Schools have sustained Tier 1 with fidelity. PBIS was implemented in the 23-24 SY at Owen J. Roberts Middle School with support from CCIU. The school team is continually assessing its implementation to maintain consistency across the building.

4. Describe the district's school-based behavior health services.

Working in conjunction with the local base service unit, Creative Health, and other area providers, the School District provides both direct service and referral opportunities for mental health support on a kindergarten to age 21 basis for students with special needs. At the elementary and secondary levels, the direct services of seven mental health specialists are utilized for interventions with both at-risk and students with special education needs. These services, if required on an ongoing basis, are specified in the student's IEP. Furthermore, in conjunction with student assistance teams, these specialists provide a link to additional community-based mental health services. The district directly employs Mental Health Scholastic Coaches who provide mental health and executive functioning support as part of the MTSS process. Individual and group counseling services are available from kindergarten to age 21 for students with special education needs. When required these services are specified in the student's IEP, and typically are provided by guidance counselors, psychologists, or mental health specialists.

5. **Describe the district's restraint procedure.**

If physical interventions are needed to maintain student safety, the Safety Care trained staff in each building are called to assist. The team supporting the student will engage in restraint for as briefly as possible to protect the student from causing harm to themselves or others. After the restraint has occurred, the case manager notifies the parent regarding the circumstances which resulted in the restraint. The parents may waive an IEP team meeting and sign the meeting waiver or request a meeting with school staff. The IEP team may also request a meeting following a restraint. The case manager then completes the restraint reporting form documenting the events preceding the restraint and the actions taken by the IEP team after the restraint, including the type of revisions, if any, made to the IEP at the meeting. This information is forwarded to the district IEP facilitators, who enter the information in the Restraint Information System Collection (RISC) system within 10 days of the restraint, 3 if an injury occurred to staff or students during the restraint.

Intensive Interagency

At this time, the Owen J. Roberts School District is able to ensure FAPE for students in any disability category. However, the Owen J. Roberts School District solicits access to some student services through the utilization of the Chester County Home, School, and Community Council and its component agencies. The agencies included in the makeup of the Chester County Home, School, and Community Council include:

1. Human Services of Chester County, Inc., for areas concerning students with mental health or adjustment problems
2. Children, Youth and Family Services from the student's county of residence for social services
3. Representation from the Association of Retarded Citizens when needed
4. Juvenile Probation from the student's county of residence when needed
5. Representatives from Mental Health and Mental Retardation from the student's county of residence when needed
6. Parent mentors when needed
7. Social Workers and Intensive Case Managers from Hospitals such as DuPont or Children's Hospital of Philadelphia when needed
8. Office of Vocational Rehabilitation when needed
9. Other organizations and agencies are brought to the table when needed

The Director of the Chester County Home, School and Community Council is employed by the Chester County Intermediate Unit. Monthly meetings are scheduled each school year, and emergency meetings may be scheduled at other times if needed. The Owen J. Roberts School District's Supervisor of Special Education, with parental written permission, will make referrals to the Council's director. Together, they determine which agencies are needed at that meeting, and the appropriate agencies are invited. At the Home, School, and Community Council meeting, the student's areas of concern are discussed, and an action plan, with responsibilities delegated to the appropriate agencies, is developed. Follow-up meetings are scheduled as needed.
